Guatemala's electricity market has been operating as a free market since 1996, when the activities of the electricity industry were separated, opening the generation and commercialization of energy to free competition.

Does Guatemala have a free trade agreement?

In addition to CAFTA-DR, Guatemala signed bilateral or regional free trade agreements with Chile, the European Union, Peru, Mexico, Colombia, Taiwan, Panama, the United Kingdom, the European Free Trade Association (EFTA) countries, and Israel and is currently negotiating a free trade agreement with South Korea.

How did Guatemala improve economic growth in 2021 & 2022?

During 2021 and 2022 the Guatemalan congress approved some key economic legislation to improve the investment climate and foster economic growth, such as a leasing law, amendments to the free trade zone law, a law to simplify administrative procedures and requirements, and an insolvency



What is Guatemala's low emission development strategy (LEDs)?

Guatemala's Climate Change Framework Law established the groundwork for Guatemala's Low Emission Development Strategy (LEDS) and is designed to align Guatemala's emissions and development targets with national planning documents in six sectors: energy, transportation, industry, land use, agriculture, and waste management.
