Overview

What are the regulations for building a new tower?

Building a new tower or collocating an antenna on an existing structure requires compliance with the Commission's rules for environmental review. These regulatory processes ensure that appropriate measures are taken to protect environmental and historic resources.

Can an EA be a violation of FCC rules?

Regardless of whether an EA is required for a project, grading soil, removing vegetation, clearing an area or otherwise beginning construction or building without following these requirements or before completion of the FCC's environmental process can constitute a violation of FCC rules and subject the party to potential enforcement action.

Does the FCC impose enforceable NEPA obligations?

The FCC treats the construction and registration of towers and facilities intended to host FCC-licensed services as major actions that trigger agency NEPA obligations. Consequently, FCC rules impose enforceable duties on licensees and applicants in order to meet the agency's NEPA obligations.

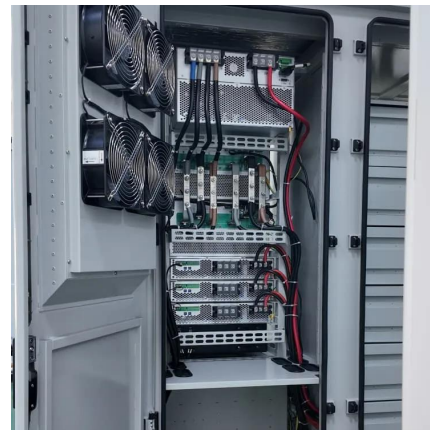

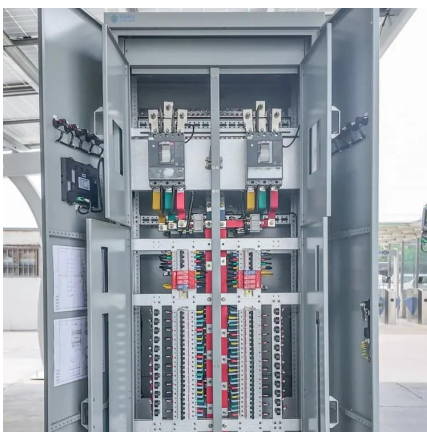
