What is a safe harbor method for wireless telecommunications depreciation?

To resolve this issue in a manner that conserves resources of both the Internal Revenue Service (Service) and taxpayers, the Service issued Revenue Procedure 2011-22, 2011-18 IRB 1, which provides a safe harbor method of accounting for the depreciation of certain tangible assets used by wireless telecommunications carriers.
