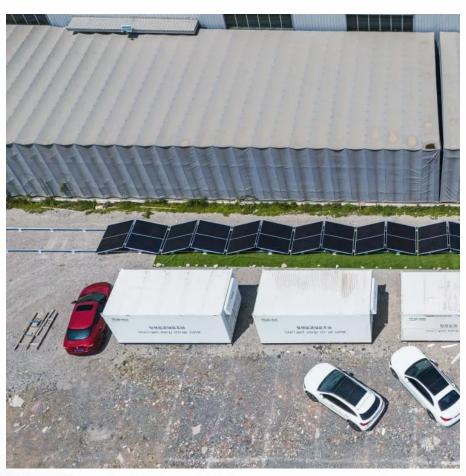


# Is there any tax on the export of photovoltaic modules







#### **Overview**

Will China reduce the export tax rebate for solar panels?

(Illustrative Photo; Photo Credit: humphery/Shutterstock.com) The Chinese Ministry of Finance and the State Administration of Taxation have revealed that the country will reduce the export tax rebate for 209 products, including solar PV cells and modules from 13% to 9%, starting from December 1, 2024.

What are the tax credits for solar photovoltaics?

The residential renewable energy tax credit currently provides a 30% tax credit for both corporations and residents who purchase and install solar photovoltaics on their businesses or homes in the United States.

Why did China reduce the export duty on photovoltaic products?

Then, with effect from the November 2024 announcement, China decided to reduce the export duty on photovoltaic (PV) products from 13% to 9%. Effective December 1, 2024, the reforms reflect China's efforts to reform its business and tax policies.

Are solar photovoltaics tax deductible?

The current subsidy provides a 30% tax credit for both corporations and residents who purchase and install solar photovoltaics. This takes 30% off the cost of any investment in this technology, making purchasing decisions more economically attractive.

Why is the solar export tax rebate coming down?

For solar, the rebate has been available since 2003. According to industry experts, the move to bring down the export tax rebate is aimed by the administration at checking overcapacity concerns because of which prices in the PV industry have dropped to record lows.


Why is China reducing solar export tax exemptions?



In 2012, China introduced a new export tax policy aimed at reforming incentives for manufacturers, including the solar industry. In 2012, however, the government began gradually reducing these exemptions to bring them into line with international trade standards and to address concerns about unfair trade practices
