Notably, solar panels imported from China remain subject to a 25% tariff under Section 301, a separate set of tariffs that continue to complicate trade and affect pricing and profitability for U.S. importers. These tariffs further underscore the complexities of navigating U.S. trade policies in the current geopolitical climate.
